Translation Competence and Language Contrast - A Multi-Method Study - Iryna Kloster 2021-10-07

Iryna Kloster applies a multi-method approach to model the translation competence based on empirical parameters, such as gaze behavior, dictionary use, revisions as well as subjective evaluations of comprehension and translation difficulty.
