The Lives of the Sophists - Philostratus (the Athenian) 1921

In Lives of the Sophists Philostratus (second to third century CE) depicts the widespread influence of Sophistic in the second and third centuries CE. Lives of Philosophers and Sophists by Eunapius (born 347 CE) is our only source concerning Neo-Platonism in the latter part of the fourth century CE. Of the distinguished Lemnian family of Philostrati, Flavius

Philostratus "the Athenian," ca. 170-205 CE, was a Greek sophist who studied at Athens and later lived in Rome. He was author of the admirable *Life of Apollonius of Tyana* (Loeb nos. 16 and 17) and of *Lives of the Sophists*, a treasury of information about notable sophists. Philostratus's sketches of sophists in action yield a fascinating picture of the predominant influence of Sophistic in the educational, social, and political life of the Empire in the second and third centuries. The Greek sophist and historian Eunapius was born at Sardis in 347 CE, but went to Athens to study and lived much of his life there teaching rhetoric and possibly medicine. He was initiated into the mysteries and was hostile to Christians. His *Lives of Philosophers and Sophists* (mainly contemporary with himself) is our only source for knowledge of Neo-Platonism in the latter part of the fourth century.

*Ovid As An Epic Poet* - Brooks Otis 2010-06-10

For the second edition of his study of the *Metamorphoses*, which was originally published in 1970, Professor Otis wrote a new concluding chapter. He took account of the constructive reviews of the first edition and of a number of important books published during the years following its publication; he also removed what had emerged as ambiguities in his collections and made some correction of emphasis to his judgments. Ovid's *Metamorphoses* is the 'other' epic of the Augustan age, at once like and unlike the greater, more profound, epic of Virgil. In his study of the poems' structure, Professor Otis shows that the real unity of the poem is to be sought not in the linkage but in the order or succession of episodes, motifs and ideas. The poem is nothing less than what Ovid called it, a *carmen perpetuum*, a narrative poem with a real continuity achieved by a gradual shift of emotional emphasis through a long series of episodes arranged in an elaborate pattern. The facts on which Professor Otis's interpretation is based are commonly known; but the interpretation itself—especially in the examination of Ovid's use of his sources—its original and illuminating.

As with all of Oswald's work, this is poetry that is made for the human voice, but here the language takes on the qualities of another element: dense, muscular, and liquid. Reading *Nobody* is like watching the ocean; we slip our earthly moorings and follow the circling shoal of sea voices into a mesh of sound and light and water—fluid, abstract, and moving with the wash of waves.

Seneca and the Self - Shadi Bartsch 2009-07-23

This new collection of essays by well-known scholars of Seneca focuses on the multifaceted ways in which Seneca, as philosopher, politician, poet and Roman senator, engaged with the question of ethical selfhood. The contributors explore the main cruxes of Senecan scholarship, such as whether Seneca's treatment of the self is original in its historical context; whether Seneca's Stoicism can be reconciled with the pull of rhetorical and literary self-expression; and how Seneca claims to teach psychic self-integration. Most importantly, the contributors debate to what degree, if at all, the absence of a technically articulated concept of selfhood should cause us to hesitate in seeking a distinctively Senecan self - one that stands out not only for the 'intensity of its relations to self', as Foucault famously put it, but also for the way in which those relations to self are couched.

THE DEAD (English Classics Series) - James Joyce 2017-11-15

Considered as one of the greatest short stories in the Western Canon, James Joyce's complex narrative "The Dead", explores the intricate issues of identity and power through the lens of language, patriarchy, and imperialism. These issues are directly tied to the longstanding political turmoil of his native Ireland and the social questions of his day. Joyce's story reveals that we often achieve what we tried to avoid by pretending to be what we are not. At 15,672 words *The Dead* is often considered a novella and the best of Joyce's shorter works. James Joyce (1882-1941) was an Irish novelist and poet, considered to be one of the most influential writers in the modernist avant-garde of the early 20th century. Joyce is best known for *Ulysses* (1922), a landmark work in which the episodes of Homer's *Odyssey* are paralleled in an array of contrasting literary styles, perhaps most prominent among these the stream of consciousness technique he perfected. Other major works are the short-story collection *Dubliners* (1914), and the novels *A Portrait of the Artist as a Young Man* (1916) and *Finnegans Wake* (1939). His complete oeuvre also includes three books of poetry, a play, occasional journalism, and his published letters.
